

NOTICE OF FULL TERMINATION OF LEASE

This NOTICE OF FULL TERMINATION OF LEASE (this "Termination"), dated as of December 8, 2016, is made by GATX CORPORATION, successor in interest to NAPA TRUST, successor in interest to PITNEY BOWES CREDIT CORPORATION, as Lessor, to hereby release all of its right, title and interest in and to the railroad equipment described on Exhibit A hereto.

WHEREAS, Lessor, as assignee of Napa Trust c/o Wilmington Trust Company, successor in interest to Pitney Bowes Credit Corporation, is party to that certain Master Equipment Lease Agreement No. 1801174 (Schedule No. 820), dated as of January 30, 1998 (the "Lease"), between Lessor and Ardent Mills, LLC (f/k/a ConAgra, Inc.), as Lessee, a memorandum of which document was filed with the Surface Transportation Board (the "Board") on December 8, 1998 at 2:40 p.m. under Recordation Number 17892-Y;

WHEREAS, by that certain Assignment and Assumption Agreement, dated as of January 31, 2000 (the "Napa Trust Assignment"), which document was filed with the Board on September 4, 2000 at 4:22 p.m. under Recordation Number 17892-AA, Pitney Bowes Credit Corporation assigned its interest as Lessor in the Lease to Napa Trust;

WHEREAS, by that certain Assignment of Master Equipment Lease Agreement (Schedule No. 820), dated as of December 8, 2016 (the "GATX Assignment"), which document was filed with the Board on December 8, 2016 at 12:45 p.m. under Recordation Number 17892-SS, Napa Trust assigned its interest as Lessor in the Lease to GATX Corporation;

WHEREAS, the aforesaid Lease has been terminated and all duties and obligations under the Lease have been fulfilled;

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the undersigned hereby acknowledges that the Lease has been terminated as to all railroad equipment covered herein except with respect to those obligations, if any, of Lessor and lessee under the Lease which expressly survive any termination thereof.
