MEMORANDUM OF RAILCAR SECURITY AGREEMENT

This Memorandum of Security Agreement (this “Memorandum”) is executed as of November 18, 2016, by and among THE DETROIT SALT COMPANY, L.C., a Michigan limited liability company, (the “Assignor”) and WELLS FARGO BANK, NATIONAL ASSOCIATION, not in its individual capacity but solely as Collateral Agent (the “Collateral Agent”) pursuant to the Indenture (as defined below).

The Assignor and the Agent have entered into a Security Agreement dated as of November 18, 2016, (as from time to time amended, modified or supplemented, the “Security Agreement”) by which the Assignor has granted a first priority security interest to the Collateral Agent, for the ratable benefit of the secured parties under that certain Indenture dated as of November 18, 2016, among Kissner Holdings LP, Kissner Milling Company Limited, Kissner USA Holdings Inc. and B.S.C. Holding, Inc., Wells Fargo Bank, National Association as trustee, the Collateral Agent and the guarantors from time to time party thereto, as amended, supplemented or otherwise modified from time to time (the “Indenture”), in all assets of the Assignor, including without limitation, all railroad equipment now owned and hereafter acquired, including without limitation, the railroad equipment described on and bearing reporting marks and road numbers as provided on Exhibit A (the “Railcars”) and all leases relating to such Railcars whether now or hereafter arising or acquired, including without limitation, the leases described on Exhibit B (the “Leases”).

The purpose of this Memorandum is to give record notice of the existence of the security interest of the Collateral Agent in the Railcars and the Leases, and all terms and conditions of the Security Agreement are incorporated by reference herein.

This Memorandum is prepared only for the public record and is being recorded with the U.S. Surface Transportation Board, as successor to the Interstate Commerce Commission, pursuant to 49 U.S.C. 11301(a).




