

PARTIAL RELEASE AND TERMINATION OF LEASE AGREEMENT

The undersigned, **THE HUNTINGTON NATIONAL BANK**, a national banking association (as assignee of BB&T Equipment Finance Corporation, "Lessor"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge any and all security interest in: (i) the railcars described on Exhibit No. 1 attached hereto (the "Cars") and (ii) the lease agreement described on Exhibit No. 2 attached hereto, solely and to the extent it pertains to the Cars (the "Sublease"), which security interest was granted to Lessor by **THE CIT GROUP/CORPORATE AVIATION, INC.** ("Grantor") pursuant to that certain Equipment Lease Agreement dated as of July 31, 2012, between Grantor and Lessor (the "Lease Agreement") and Lease Supplement No. 6 thereto dated as of July 31, 2012 (the "Lease Supplement"). The Lease Supplement and the Lease Agreement, to the extent incorporated in or relating to the Lease Supplement, and solely as it pertains to the Lease Supplement and the Cars, are hereinafter collectively referred to as the "Lease". Three Memoranda of Equipment Lease Agreement were duly filed and recorded with the Surface Transportation Board on July 31, 2012 under Recordation Numbers 25991-K, 21737-G, and 20972-UU. Three Memoranda of Security Interest evidencing Lessor's security interest in the Sublease were duly filed and recorded with the Surface Transportation Board on July 31, 2012 under Recordation Numbers 25991-L, 21737-H, and 20972-VV.

Effective immediately herewith, the Lease referenced above is terminated, and the Cars identified on Exhibit No. 1 hereto and the Sublease identified on Exhibit No. 2 hereto (solely and to the extent such Sublease pertains to the Cars) shall be free and clear of any liens, encumbrances and interests of Lessor. Lessor agrees to and authorizes the filing by Grantor, or its designee, of this Partial Release and Termination of Lease Agreement with the Surface Transportation Board to terminate any filings evidencing Lessor's security interests under the Lease.

The terminations, releases and discharges set forth herein are made in each case without prejudice to the rights or obligations of the parties which expressly survive the termination of the Lease.
