

MEMORANDUM OF ASSIGNMENT

THIS MEMORANDUM OF ASSIGNMENT dated as of November 21, 2016, is between **GREENBRIER LEASING COMPANY LLC**, an Oregon limited liability company (“Greenbrier”), and **RAILCAR HOLDINGS PAS I LLC**, a Delaware limited liability company (“PAS I”).

The parties to this Memorandum hereby acknowledge and confirm the following:

A. Greenbrier, as lessor, has leased seventy-eight (78) 33,700 gallon DOT112J340W LPG tank railcars, marked and numbered GBRX 705345 through GBRX 705422, inclusive (the “Cars”) pursuant to that certain Master Lease Agreement dated as of June 21, 2016, and Schedule No. 2 dated as of June 21, 2016, thereto (the “Schedule”, and the Schedule together with the Lease Agreement as it relates to the Schedule, each as amended, modified, extended, supplemented, restated and/or replaced from time to time, the “Lease”) to PBF Holding Company LLC.

B. A Memorandum of Lease was filed with respect to Schedule No. 2 with the U.S. Surface Transportation Board on August 22, 2016, under recordation number 32295.

C. Greenbrier and PAS I are parties to that certain Assignment Agreement dated November 21, 2016, pursuant to which Greenbrier has assigned all of its right, title and interest under the Lease, as it pertains to periods on and after November 21, 2016, and the Cars, to PAS I.
