MEMORANDUM OF LEASE

RIDER NO. 11

This is a Memorandum of Rider No. 11 dated effective November 1, 2015, to a Lease Agreement made and entered into as of October 1, 2003, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company formerly known as Greenbrier Leasing Corporation ("Lessor") and Wisconsin Central Ltd., a Delaware corporation ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor fifty-nine (59) 73-foot, 286,000 lb. GRL riserless deck center partition railcars bearing marks and numbers as indicated in the attached Rail Equipment List.


