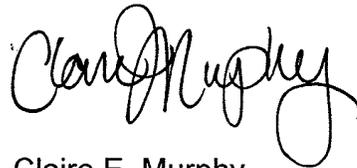

MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE
(Surface Transportation Board)

THIS MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE (this “Memorandum”) dated as of June 3, 2015 is between **ALLIED ENTERPRISES, INC.** (the “Assignor”) and **RLH1 LLC** (the “Assignee”).

The parties to this Memorandum hereby acknowledge and confirm the following:

A. The Assignor, as lessor, has leased to Sunny Farms Landfill, LLC, as lessee (the “Lessee”), thirty nine (39), 2004 built high capacity, gondola railcars, as more fully identified on Schedule 1 attached hereto (the “Railcars”) under that certain Lease Agreement dated as of October 13, 2011 and the Rider No. 1 thereto dated the same date, by and between Assignor and Sunny Farms Landfill, LLC, as Lessee (collectively, the Lease”).

B. The Assignor, as assignor, and the Assignee, as assignee, are parties to that certain Assignment of Lessor’s Interest in Lease, dated as of even date herewith, pursuant to which the Assignor has assigned to the Assignee the rights of “Lessor” under the Lease. The terms of the assignment are more particularly set forth in the above-referenced Assignment of Lessor’s Interest in the Lease.

C. The parties hereto wish to show for public record this Memorandum and accordingly have caused this Memorandum to be executed by their officers thereunto duly authorized, as of the date first above written. This Memorandum may be executed in counterparts, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.
