THIS MEMORANDUM OF LEASE TERMINATION (this "Memorandum"), dated as of December 31, 2014, is made by FARM CREDIT LEASING SERVICES CORPORATION, a federally-chartered corporation ("Lessor"), and pertains to that certain Lease Agreement and Addendum to Lease Agreement, each dated as of November 14, 1994 (collectively, the "Lease"), by and between Lessor and Western Fuels Association, Inc., a Wyoming corporation ("Lessee").

WHEREAS, Lessor and Lessee entered into the Lease, which was filed with the Surface Transportation Board on January 17, 1995 with recordation number 17271-D, whereby Lessor agreed to lease to Lessee certain railcars as more particularly described on Schedule 1 hereto (the "Equipment"); and

WHEREAS, the Lease is being terminated as of December 31, 2014.


NOW, THEREFORE, Lessor desires to clarify the public record to state as follows:
