


**MEMORANDUM OF SCHEDULE #9 TO FULL SERVICE MASTER LEASE AGREEMENT**

THIS MEMORANDUM OF SCHEDULE #9 TO FULL SERVICE MASTER LEASE AGREEMENT is effective as of March 12, 2015, by and between MIDWEST RAILCAR CORPORATION, an Illinois Corporation ("Lessor"), and PERDUE AGRIBUSINESS LLC, a Maryland Limited Liability Company ("Lessee"), with reference to the following:




