AFFIDAVIT

Before me, a notary public, in and for the County and State aforesaid, appeared Mark Stefani, who first being duly sworn, stated as follows:

1. I am the Vice President of General Electric Railcar Services Corporation ("GERSCo"), and I am authorized to make this Affidavit on behalf of the Corporation.
2. In 1989, GERSCo acquired, directly or indirectly, certain assets from Brae Transportation, Inc., which was formerly known as Brae Corporation.
3. SSI Rail Corp. was merged with and into Itel Corporation effective December 30, 1977.
4. On or about late 1987, Itel Corporation or its affiliates acquired certain assets from Evans Railcar Leasing Company, formerly known as United States Railway Leasing Company, which were sold in connection with the bankruptcy of the corporate parent of Evans Railcar Leasing Company.
5. In or around 1989, Itel Corporation acquired Pullman Leasing Company, formerly known as Signal Capital Corporation, inter alia, after which Pullman Leasing Company was renamed Itel Rail Corporation.
6. Effective June 1, 1992, certain affiliates of GERSCo entered into certain agreements with Itel Corporation, Itel Rail Corporation and Rex Railways, Inc. whereby (a) Itel Corporation, Itel Rail Corporation and Rex Railways, Inc. contributed substantially all of their railcar and railcar lease assets to Railcar Associates, L.P. and (b) Railcar Associates, L.P. leased such railcars and transferred such railcar leases to an affiliate of GERSCo.
7. Effective June 1, 2010, pursuant to an assignment of rights under the leases described above, General Electric Capital Corporation purchased all of the assets of Railcar Associates, L.P., which assets have since been transferred to GERSCo.

8. Certain filings identified on Exhibit A (the "Lease Filings") hereto were made with the Interstate Commerce Commission and the Surface Transportation Board relating to leases by Brae Corporation, Brae Transportation, Inc., SSI Rail Corp., United States Railway Leasing Company, Evans Railcar Leasing Company, Pullman Leasing Company, Rex Railways, Inc., Itel Corporation and Itel Rail Corporation (a) may pertain to leases and/or railcars subsequently transferred to GERSCo and (b) have termination dates which cannot be determined on the face of documents currently on file.

9. In anticipation of a sale of a substantial portion of its boxcar assets to GATX Corporation, the Lease Filings have been brought to the attention of GERSCO.

10. GERSCo states that (a) of the assets it proposes to sell to GATX Corporation, it treats none as being subject to any of the leases or other obligations identified or referenced in the Lease Filings and (b) to its knowledge (without accepting any duty of enquiry), none of the Lease Filings relate to continuing or current obligations of any party.



This Affidavit is submitted for filing with the Surface Transportation Board as best evidence that the Lease Filings are terminated and that GERSCO thereafter held title to rail equipment it owned subject to the Lease Filings free and clear of any liens or encumbrances imposed by the Lease Filings.


