MEMORANDUM OF LEASE AND FOURTH LEASE RENEWAL

This MEMORANDUM OF LEASE AND FOURTH LEASE RENEWAL is made and entered into as of April 1, 2016, by and between ATEL LEASING CORPORATION, AS TRUSTEE FOR ATEL CAPITAL EQUIPMENT FUND VIII, LLC, AS OWNER ("ATEL"), located at 600 Montgomery Street, 9th Floor, San Francisco, CA 94111 and FERROUS PROCESSING AND TRADING COMPANY ("FPT"), located at 9100 John Kronk Street, Detroit, MI 48210.

WITNESSETH

Pursuant to a Master Lease Agreement (Full Service) (the "Lease Agreement") dated as of July 1, 2004 and Lease Schedule No. 2 thereto dated as of January 26, 2006, which incorporates the terms and conditions of the Lease Agreement and together with the Lease Agreement is the ("Lease"), ATEL had agreed to lease to FPT and FPT had agreed to lease from ATEL one hundred (100) used 263,000GRL capacity gondolas bearing car mark numbers FPTX 84001 through FPTX 84100 inclusive (the "Cars") for an initial term of seventy-two (72) months that commenced on April 1, 2006 and ended on March 31, 2012.

Pursuant to a First Amendment to Lease Schedule No. 2 dated as of January 9, 2012, (the "First Amendment"), ATEL had agreed to continue to lease to FPT and FPT had agreed to continue to lease from ATEL the Cars for an additional term of twelve (12) months commencing on April 1, 2012, and continuing through and including March 31, 2013 (the "Extended Term").

A Memorandum of Lease and First Renewal with respect to Lease Schedule No. 2 was duly filed and recorded with the Surface Transportation Board (the "Board") pursuant to the provisions of 49 U.S.C. Section 11301 and 49 CFR 1177, on January 27, 2012, at 10:43 a.m. under Recordation Number 30073.

A Memorandum of Partial Termination of Lease and First Lease Renewal with respect to Lease Schedule No. 2 was duly filed and recorded with the Board pursuant to the provisions of 49 U.S.C. Section 11301 and 49 CFR 1177, on July 31, 2012, at 1:46 p.m. under Recordation Number 30073-A.

Pursuant to a Second Amendment to Lease Schedule No. 2 dated as of December 31, 2012, (the "Second Amendment"), ATEL and FPT agreed to replace the Extended Term with a fifteen (15) month renewal term commencing on January 1, 2013, and continuing through and including March 31, 2014 (the "Renewal Term").

Pursuant to the Second Amendment the Lease was amended by deleting the following eleven (11) Cars from Exhibit A: FPTX 84007, 84009, 84051, 84053, 84054, 84062, 84063, 84066, 84067, 84069 and 84098.

Pursuant to a Third Amendment to Lease Schedule No. 2 dated as of April 1, 2014, (the "Third Amendment"), ATEL agreed to continue to lease to FPT and FPT agreed to continue to

lease from ATEL the Cars for an additional term of twelve (12) months commencing on April 1, 2014, and continuing through and including March 31, 2015 (the "Second Renewal Term").

Pursuant to the Third Amendment the Lease was amended by deleting the following fourteen (14) Cars from Exhibit A: FPTX 84003, 84006, 84016, 84030, 84039, 84040, 84043, 84050, 84052, 84056, 84064, 84073, 84078 and 84095.

A Memorandum of Lease and Second Renewal with respect to Lease Schedule No. 2 was duly filed and recorded with the Surface Transportation Board (the "Board") pursuant to the provisions of 49 U.S.C. Section 11301 and 49 CFR 1177, on January 8, 2015, at 01:03 p.m. under Recordation Number 30073-B.

Pursuant to a Fourth Amendment to Lease Schedule No. 2 dated as of April 1, 2015, (the "Fourth Amendment"), ATEL agreed to continue to lease to FPT and FPT agreed to continue to lease from ATEL the Cars for an additional term of twelve (12) months commencing on April 1, 2015, and continuing through and including March 31, 2016 (the "Third Renewal Term").

Pursuant to the Fourth Amendment the Lease was amended by deleting the following three (3) Cars from Exhibit A: FPTX 84011, 84037 and 84045.

A Memorandum of Lease and Third Renewal with respect to Lease Schedule No. 2 was duly filed and recorded with the Board pursuant to the provisions of 49 U.S.C. Section 11301 and 49 CFR 1177, on April 1, 2015, at 12:29 p.m. under Recordation Number 30073-C.

Pursuant to a Fifth Amendment to Lease Schedule No. 2 dated as of April 1, 2016, (the "Fifth Amendment"), ATEL has agreed to continue to lease to FPT and FPT has agreed to continue to lease from ATEL the Cars for an additional term of twelve (12) months commencing on April 1, 2016, and continuing through and including March 31, 2017 (the "Fourth Renewal Term").

This Memorandum of Lease and Fourth Lease Renewal has been executed and delivered by the parties for the purpose of recording and giving notice of the Lease.

IN WITNESS WHEREOF, ATEL and FPT have each executed this instrument as of the day and year first above written. Each of the undersigned certifies that he/she holds the title set forth below, that this instrument was signed on behalf of his/her corporation by authority of its Board of Directors and that the execution of this instrument was the free act and deed of his/her corporation.
