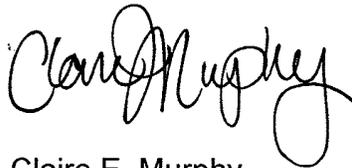

**THIS MEMORANDUM OF EQUIPMENT LEASE AGREEMENT (GATX TRUST NO. 2016-1D)** made and entered into on July 1, 2016 (this “**Memorandum**”) between **U.S. BANK NATIONAL ASSOCIATION**, not in its individual capacity but solely as Owner Trustee under the Trust Agreement, as Lessor (“**Lessor**”) and **GATX CORPORATION**, a New York corporation, as Lessee (“**Lessee**”).

W I T N E S S E T H:


