MEMORANDUM OF RAILCAR LEASE

THIS MEMORANDUM OF RAILCAR LEASE dated as of this 1st day of August, 2016, and effective as of September 1, 2016 is made by THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation, with an address at 30 South Wacker Drive, Suite 2900, Chicago, Illinois 60606 (the "Lessor"), and GREEN PLAINS LOGISTICS LLC, a Delaware limited liability company, with an address at 450 Regency Parkway, Omaha, NE 68114 (the "Lessee" and, together with the Lessor, the "Parties").
