

MEMORANDUM OF ASSIGNMENT

THIS MEMORANDUM OF ASSIGNMENT dated as of November 21, 2016, is between GREENBRIER LEASING COMPANY LLC, an Oregon limited liability company ("Greenbrier"), and RAILCAR HOLDINGS PAS I LLC, a Delaware limited liability company ("PAS I").

The parties to this Memorandum hereby acknowledge and confirm the following:

A. Greenbrier, as lessor, has leased seventy (70) 25,498 gallon exterior coiled and insulated DOT111A100W1 tank railcars, bearing marks and numbers GBRX 704200 through 704269, inclusive (the "Cars") pursuant to that certain Master Lease Agreement dated as of June 1, 2016 (the "Lease Agreement"), and that certain Schedule No. 1 thereto dated as of June 1, 2016 (the "Schedule", and together with the Lease Agreement as it relates to the Schedule, the "Lease") to HollyFrontier Refining & Marketing LLC.

B. That certain Memorandum of Lease Schedule No. 1 was filed with respect to the Schedule with the U.S. Surface Transportation Board on August 5, 2016, under recordation number 32278.
