

The undersigned, BANC OF AMERICA LEASING & CAPITAL LLC, Lessor, publishes this notice that the certain Locomotive Net Leasing Agreement, dated as of December 20, 2013 between Banc of America Leasing & Capital LLC, as Lessor, and BNSF Railway Company, as Lessee, as subsequently amended or modified (the "Lease"), is hereby fully terminated except with respect to those obligations, if any, of Lessor and Lessee under the Lease which expressly survive any termination thereof.
