

SCHEDULE NO. 1

This is a Memorandum of Schedule No. dated as of June 17, 2016, to a Lease Agreement made and entered into as of June 17, 2016, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and Greenfield Logistics, LLC, a Delaware limited liability company ("Lessee").


