Continental Bank N.A., as Trustee (the "Seller") in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration the receipt of all of which by it is hereby acknowledged, has bargained, sold, conveyed, transferred and delivered, and by these presents does hereby bargain, sell, grant, convey, transfer and deliver unto Chicago and North Western Transportation Company (the "Buyer"), the unit(s) of equipment described in Schedule A attached hereto ("the Equipment"):

TO HAVE AND TO HOLD the same unto the Buyer, its successors and assigns forever;

EXCEPT AS PROVIDED IN THE IMMEDIATELY PRECEDING PARAGRAPH, SELLER HEREBY DISCLAIMS ANY AND ALL REPRESENTATIONS AND WARRANTIES, WHETHER EXPRESS OR IMPLIED. BUYER ACKNOWLEDGES AND AGREES THAT (i) SELLER SHALL NOT BY VIRTUE OF HAVING SOLD THE GOODS, BE DEEMED TO HAVE MADE ANY REPRESENTATION OR WARRANTY AS TO THE MERCHANTABILITY, FITNESS, QUALITY, DESIGN OR CONDITION OF, OR AS TO THE QUALITY OF THE MATERIAL OR WORKMANSHIP IN, THE GOODS AND (ii) SELLER DISCLAIMS AND BUYER WAIVES ALL OTHER WARRANTIES, GUARANTEES OR LIABILITIES, EXPRESS OR IMPLIED, ARISING BY LAW, EQUITY OR OTHERWISE, INCLUDING, WITHOUT LIMITATION, ANY OBLIGATION OR LIABILITY IN TORT OR CONSEQUENTIAL DAMAGES, it being agreed and understood that all such risks are to be borne by Buyer. Buyer purchases the Goods "AS IS" and "WHERE IS" and the description of the goods given herein is for the sole purpose of identification and is not part of the basis of the bargain.


