

TERMINATION AGREEMENT AND RELEASE MAY 17 1991 -3 10 PM  
INTERSTATE COMMERCE COMMISSION

WHEREAS, SIGNET LEASING AND FINANCIAL CORPORATION ("SIG") and THE MARYLAND AND PENNSYLVANIA RAILROAD COMPANY ("MPA") are parties to a Lease of Railroad Equipment ("Lease") dated as of December 4, 1987, covering seven (7) boxcars bearing road numbers listed on Exhibit A attached hereto and made a part hereof (the "Cars") which Lease was filed with the Interstate Commerce Commission (the "ICC") on April 19, 1988, under Recordation No. 15586; and

WHEREAS, SIG and MPA desire to terminate the Lease and release the lien created pursuant thereto;

NOW, THEREFORE, in consideration of the mutual covenants contained herein and for other valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree:

1. Termination. The Lease is terminated and the Cars are released from the liens, assignment and security interest created thereunder.

2. Filing. The parties consent to the filing of this Termination and Release and any other necessary documents with the Interstate Commerce Commission (and, if necessary, with any other regulatory or governmental entity) to effect a release of this lien of record existing against the Cars.

3. Counterparts. This Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed shall be deemed to be an original and all of which when taken together shall constitute one and the same agreement.


