

SURFACE TRANSPORTATION BOARD

The undersigned, WILMINGTON TRUST COMPANY, not in its individual capacity but solely as Indenture Trustee (the "Indenture Trustee"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, hereby gives notice that it does hereby terminate, release and discharge any and all security interests held by it on all railroad equipment granted pursuant to the Indenture and Security Agreement (1999C-1), dated as of September 29, 1999, as amended, modified or supplemented (the "Indenture and Security Agreement"), between Allfirst Financial Center National Association, as Owner Trustee (the "Owner Trustee"), and the Indenture Trustee.
