

MEMORANDUM OF ASSIGNMENT OF LEASE

SURFACE TRANSPORTATION BOARD

This Memorandum of Assignment of Lease between The Fifth Third Leasing Company, 38 Fountain Square Plaza, MD 10904A, Cincinnati, OH 42563 (the "Assignor"), and SunTrust Equipment Finance & Leasing Corp., 300 East Joppa Road, 7th Floor, Towson, MD 21286 (the "Assignee") is effective as of December 31, 2009.

1. This instrument relates to (i) that certain Master Rail Car Lease Agreement dated as of October 11, 2004 (the "Lease Agreement") and the related Equipment Schedule No. 008 (the "Schedule" which term shall also include any and all riders, addenda and exhibits attached to the Schedule, and which together with the Lease Agreement shall collectively be referred to as the "Lease"), between ICX Corporation ("ICX"), as lessor, and Carolina Power & Light Company (d/b/a Progress Energy Carolinas, Inc.) ("CP&L"), as lessee, pursuant to which ICX leased to CP&L 115 Johnston 286K GRL railcars numbered PGNX 7105-7186, inclusive, 7188-7214, inclusive, and 8100-8105, inclusive (the Equipment"); and (ii) that certain agreement dated as of March 28, 2005 pursuant to which ICX assigned its interests in the Equipment and the Lease to Assignor, and Assignor acquired all of the rights, title, and interest in and to the Equipment and the Lease of ICX (the "Assignment").
2. A Memorandum of Lease dated as of December 6, 2004 with respect to the Lease Agreement was recorded with the Surface Transportation Board (the "Board") on December 7, 2004 at 4:00 pm under Recordation No. 25323; a Memorandum of Supplement to Lease dated as of March 17, 2005 with respect to the Schedule was recorded at the Board on March 21, 2005 at 2:35 pm under Recordation No. 25323-H, and a Memorandum of Assignment of Lease dated as of March 28, 2005 with respect to the Assignment was recorded at the Board on March 28, 2005 at 2:21 pm under Recordation No. 25323-J
3. Pursuant to certain agreements dated as of December 29, 2009, Assignor assigned its interest in the Equipment and the Lease to Assignee. As a result of these assignments, Assignee has acquired all of the rights, title, and interest in and to the Equipment and the Lease of Assignor.
4. The terms and provisions of the Lease and the assignments are more particularly set forth in the Lease Agreement, the Schedule, and the assignment agreements and are incorporated herein by reference
5. This Memorandum of Assignment of Lease may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment of Lease.


