The Seller further warrants that the aforesaid Property is free and clear of all claims, liens, security interests and other encumbrances of record by or in favor of any person claiming by, through or under the Seller other than such claims, liens, security interests and other encumbrances which are the responsibility of Canadian National Railway Company in its capacity as Lessee under the Equipment Lease, Assignment, Chattel Mortgage and Security Agreement dated as of June 1, 1970.

The aforesaid property is being sold here on an "as-is, where is" basis and "with all faults". The seller makes no other representation or warranty, either express or implied, including any implied warranty of merchantability or description or fitness for a particular purpose or use, and expressly disclaims liability for lost profit or for indirect, incidental, consequential, or commercial losses and all other obligations or liabilities.


