TERMINATION AND RELEASE

SURFACE TRANSPORTATION BOARD

This Termination and Release is entered into by Bank One Trust Company, N. A. ("Bank One"), a national banking association, as successor in interest to The Liberty National Bank and Trust Company of Oklahoma City, on this 15 day of September, 2000.

WITNESSETH:

WHEREAS, The Liberty National Bank and Trust Company of Oklahoma City, as trustee under a trust agreement (the "Trust Agreement") dated as of December 1, 1972 with General Electric Capital Corporation ("GECC"), entered, as trustee under the Trust Agreement and not in its individual capacity, into those certain agreements and documents set forth on Annex A hereto (the "Agreements") in connection with the purchase by the trust created pursuant to the Trust Agreement (the "Trust") of certain railroad equipment, a schedule of which is attached as Annex B hereto (the "Equipment") and the lease of the Equipment to (x) Weyerhaeuser Company and (y) Texas, Oklahoma & Eastern Railroad Company; and

WHEREAS, memoranda of the rights and interests of The Liberty National Bank and Trust Company of Oklahoma City, the Trust and GECC, as beneficiary of the Trust, as secured parties with respect to the Equipment, have been recorded with the Surface Transportation Board under Recordation Nos. 6834, 6851, 6852, 6876 and 7053 (the "STB Memoranda"); and

WHEREAS, the Agreements were terminated in accordance with their respective terms on or before July 16, 1993, on which date the Equipment (as well as certain additional railroad equipment) was sold by GECC to The First National Bank of Maryland (now Allfirst Bank) and the Trust has no further interest therein; and

WHEREAS, subsequent to entering into the Agreements, Bank One became successor in interest to The Liberty National Bank and Trust Company of Oklahoma City;

NOW THEREFORE, the undersigned, in its capacity as trustee and not in its individual capacity hereby agrees and acknowledges, that:

It hereby TERMINATES and RELEASES any right, title or interest whatsoever, which it, in its capacity as trustee, and not in its individual capacity, the Trust or GECC, as beneficiary of the Trust, might otherwise have had under

any of the Agreements, whether as security for payment of amounts due under the Agreements or otherwise and further RELEASES any other party to any of the Agreements from any claims, obligations and liabilities to it (in its capacity as trustee and not in its individual capacity), the Trust or GECC, as beneficiary thereunder arising out of the transactions evidenced thereby.

Without limiting the generality of the foregoing, it hereby TERMINATES and RELEASES any right, title or interest whatsoever, which it, in its capacity as trustee, and not in its individual capacity, the Trust or GECC, as beneficiary of the Trust, might otherwise have had covered by the STB Memoranda.
