**WHEREAS, Wells Fargo Bank, National Association** (predecessor-in-interest to *Manufacturers Hanover Trust Company of California* [predecessor-in-interest to *Chase Manhattan Bank and Trust Company, National Association*]) as trustee (the "Trustee") entered into the following agreements:

**Equipment Trust Agreement dated as of May 1, 1974** [recordation number ("RN"): 7522] with **Exchange National Bank of Chicago** (predecessor-in-interest to *LaSalle Bank, National Association*) as owner-trustee (the "Owner-Trustee) as amended by a Supplement No. 1 dated as of July 1, 1975 [RN: 7522-C] (secured by an interest in i) the rolling stock specified in the 'Schedule I - Equipment Trust Agreement' attached hereto as Exhibit A and ii) the Lease of Equipment dated as of May 1, 1974 [RN: 7522-A], as amended by such Supplement No. 1 and a Lease Amendment Agreement dated as of October 2, 1977 [RN: 7522-D], between the Owner Trustee and **Canadian National Railway Company**, of such rolling stock);

**WHEREAS**, with reference to the aforementioned recordation numbers, the various documents described hereinabove were filed with the Interstate Commerce Commission (now the Surface Transportation Board) pursuant to Section 20c of the *Interstate Commerce Act* (now 49 U.S.C. 11301);

**WHEREAS**, the original Equipment Trust Agreement and the original Lease of Equipment were deposited on May 30, 1974 with the Registrar General of Canada pursuant to Section 86 of the *Railway Act of Canada* (now Section 105 of the *Canada Transportation Act*);

**AND WHEREAS**, the Owner Trustee has performed its obligations under the aforementioned Equipment Trust Agreement, as it may have been amended or supplemented from time to time.

**IN WITNESS WHEREOF**, the Trustee wishes to show for the public record that i) the aforementioned Equipment Trust Agreement has been terminated and ii) it hereby releases its security interest in x) the aforementioned Lease of Equipment and y) all the
