MASTER RELEASE OF TRUSTEE dated as of March 1, 2000.

WHEREAS, Inter National Bank of Miami (predecessor-in-interest to *First Union National Bank*) as trustee (“Trustee”) and **First Security Bank of Utah, N.A.** (now known as *First Security Bank, N.A.*) as owner-trustee (“Owner-Trustee”) entered into the following agreements:

Equipment Trust Agreement dated as of October 15, 1973 [Recordation Number (“RN”): 7246] as amended by an **Amendment** dated as of May 15, 1974 [RN: 7246-E] (secured by an interest in i) the rolling stock specified in the ‘Schedule I - Equipment Trust Agreement No. 1’ attached hereto as Exhibit A and ii) the **Lease of Equipment No. 1** dated as of October 15, 1973 [RN: 7246-C], and **Lease of Equipment No. 1-A** dated as of January 15, 1974 [RN: 7246-A], as amended by such Amendment between the Owner Trustee as lessor and **Canadian National Railway Company** (“Lessee”) as lessee of such rolling stock);

Equipment Trust Agreement dated as of January 1, 1974 [RN: 7300] as amended by an **Amendment** dated as of March 1, 1974 [RN: 7300-C] (secured by an interest in i) the rolling stock specified in the ‘Schedule I - Equipment Trust Agreement’ attached hereto as Exhibit B and ii) the **Lease of Equipment** dated as of January 1, 1974 [RN: 7300-A] between the Owner Trustee as lessor and Lessee as lessee of such rolling stock);




