SELLER HEREBY EXPRESSLY DISCLAIMS AND NEGATES ANY IMPLIED OR EXPRESSED REPRESENTATION OR WARRANTY OF ANY AND EVERY KIND, INCLUDING ANY AS TO THE CONDITION, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE, except that there are no Lessor Liens (as such term is defined in Appendix 1 to the Participation Agreement dated as of March 30, 2005 among the Lessee, the Lessor, ABN AMRO Bank N.V., as administrative agent, ABN AMRO Advisory, Inc., as collateral agent, and the participants from time to time party thereto).
