Memorandum of Lease Assignment (BNSF 2009-B), effective as of July 15, 2009, by and between BNSF 2009-B LLC, a Delaware limited liability company, as Lessor ("*Lessor*"), and Wells Fargo Bank Northwest, National Association, a national banking association, as Indenture Trustee ("*Indenture Trustee*").

WITNESSETH:

1. The Lessor and BNSF Railway Company ("*Lessee*") have entered into an Equipment Lease Agreement (BNSF 2009-B), dated as of July 1, 2009 (as amended, supplemented or modified, the "*Lease*"), covering certain railroad equipment bearing reporting marks as listed on Exhibit A attached hereto.


