(successor to First Security Bank, National Association and to Wells Fargo Bank Northwest, National Association), as Lessor (the "Lessor"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, hereby gives notice that it has terminated the Restated Lease Supplement No. 3, incorporating by reference all of the terms, conditions and provisions of, the Equipment Leasing Agreement dated as of July 21, 1999 between Lessor, and ALABAMA POWER COMPANY, as Lessee (the "Lessee") (as amended by that certain Amendment No. 1 dated as of August 17, 2006 and that certain Amendment No. 2 dated as of August 17, 2010 and as further amended and supplemented from time to time) (the "Lease") as it affects the railroad equipment at any time described in that Lease (the "Railroad Equipment").
