MEMORANDUM OF TERMINATION OF LEASE

THIS MEMORANDUM OF TERMINATION OF LEASE ("Termination") is made as of August 26, 2013 by Greenbrier Leasing Company LLC, formerly known as Greenbrier Leasing Corporation (the "Lessor").

1. Lessor and GWI Leasing Corporation ("Lessee"), as lessee, entered into a Lease Agreement dated as of March 1, 2000;
2. Lessor and Lessee entered into a Rider No. 1 dated as of March 1, 2000 to such Lease Agreement, and subsequently amended such Rider No. 1 from time to time (such Rider, as so amended, the "Lease") covering the one hundred fifty-seven (157) 60-foot, Plate F boxcars marked and numbered as set forth in the Rail Equipment List attached as Exhibit A;
3. To evidence the above described Lease, a Memorandum of Lease Agreement was filed at the Surface Transportation Board on December 26, 2002 under recordation number 24259 (the "Memorandum of Lease");
4. The Memorandum of Lease was subsequently amended by an Amendment to Memorandum of Lease dated July 1, 2004 and filed at the Surface Transportation Board on September 5, 2006 under recordation number 24259-A, and Amendment No. 2 to Memorandum of Lease dated November 1, 2007 and filed at the Surface Transportation Board on June 5, 2008 under recordation number 24259-B;
5. The Lease has terminated; and
6. Lessor is filing this Termination, acknowledging for the public record that the Memorandum of Lease is terminated.

IN WITNESS WHEREOF, Lessor has caused this Termination to be duly executed by its duly authorized officer as of the date and year first above written, and the undersigned declares under penalty of perjury that he or she holds the title indicated below and that the execution of this Termination of Lease was the free act and deed of the company.


