

NOTICE OF PARTIAL TERMINATION OF LEASE

THIS NOTICE OF PARTIAL TERMINATION OF LEASE (this "Notice") is made this 29th day of August, 2013, by GRH 2006-1, LLC formerly known as ARH 2006-1, LLC, as successor in interest to AllCapital Rail Management, LLC ("GRH"), pursuant to that certain Master Car Lease Agreement, and Schedule No. 01 to Master Car Lease Agreement, each dated as of April 9, 2007, between AllCapital Rail Management, LLC and Poet Nutrition, Inc. (as amended and supplemented, the "Lease").

WHEREAS, the Lease covered those certain railcars particularly identified in Exhibit 1 hereto (the "Units");

WHEREAS, the Lease and a Memorandum of Assignment Agreement with respect to the Lease were duly recorded with the Surface Transportation Board on June 29, 2007 under Recordation Numbers 27046 and 27046-A and with the Registrar General of Canada on June 29, 2007 under Document Keys 18591 and 18592:
