NOTICE OF TERMINATION OF LEASE

SURFACE TRANSPORTATION BOARD

The undersigned, PNC Equipment Finance, LLC (assignee of The Fifth Third Leasing Company and ultimate successor in interest to Pitney Bowes Credit Corporation), Owner and Lessor, publishes this notice that the Master Equipment Lease Agreement with Lease Schedule No. 817 (the "Schedule No. 817") is hereby terminated except with respect to those obligations, if any, of the parties thereto which, by their terms, expressly survive the termination thereof.

A Memorandum of Schedule No. 817 between Pitney Bowes Credit Corporation, as Lessor, and ConAgra, Inc., as Lessee, was originally filed with the Surface Transportation Board (the "Board") on December 29, 1995 under Recordation Number 17892-R, which was thereafter assigned by Pitney Bowes Credit Corporation to Crestar Leasing Corporation, a Memorandum of which was filed with the Board on December 18, 1998 under Recordation Number 17892-Z.

Schedule No. 817 was subsequently assigned by SunTrust Leasing Corporation (formerly Crestar Leasing Corporation) to The Fifth Third Leasing Company, a Memorandum of which was filed with the Board on March 31, 2004 under Recordation Number 17892-CC, and was finally assigned by The Fifth Third Leasing Company to PNC Equipment Finance, LLC, a Memorandum of which was filed with the Board on September 29, 2006 under Recordation Number 17892-DD.

The railroad equipment covered by Schedule No. 817 consisted of two hundred and fifty-five (255) covered hopper railcars identified on Exhibit A attached hereto.
