

**RELEASE OF LIEN**

**WHEREAS**, J.P. Morgan Trust Company, National Association(ultimate successor in interest to Harris Trust and Savings Bank), not in its individual capacity but as Security Trustee pursuant to a Security Agreement-Trust Deed dated as of February 1, 1975, as amended, (the "Security Agreement") between Security Trustee and The Bank of New York (ultimate successor in interest to Trust Company for USL, Inc. as Trustee under U.C. Trust No. 11 and as Lessor under the Lease of Railroad Equipment dated as of February 1, 1975 with respect to certain railcars with Union Carbide Corporation as Lessee), which Security Agreement-Trust Deed was recorded with the Interstate Commerce Commission on July 30, 1975 at 10:05 a.m. and assigned recordation number 8012;

**WHEREAS**, the indebtedness secured thereby was paid in full on March 31, 2003 and the obligations of the Trustee have therefore been paid and satisfied in full;

**WHEREAS**, pursuant to Section 11.04 of the Security Agreement-Trust Deed, Security Trustee agrees to execute this Release to evidence for the public record the satisfaction and release of its lien;


**NOW, THEREFORE**, the Security Trustee, for due consideration, pursuant to the provisions of Section 11.04 of the Security Agreement-Trust Deed does hereby release, demise, convey and quitclaim unto the Trustee and its successors and assigns whatever right, title, lien or interest which the Security Trustee has or may have under the Security Agreement-Trust Deed or by virtue of the recording of the Security Agreement-Trust Deed with the Interstate Commerce Commission.
