THIS TERMINATION OF LEASE is entered into as of July 30, 2012 ("Release") between The Andersons, Inc., ("Lessor"), and Westlake Longview Corporation, ("Lessee").

WHEREAS, Lessor and Lessee are successor parties to the Equipment Lease Agreement (ECC Trust No. 1994-1), dated as of December 2, 1994, along with its related Lease Supplement No. 1, dated December 2, 1994 originally among Eastman Chemical Company, as lessee, Shawmut Bank Connecticut, National Association, as owner trustee and General Foods Credit Investors No. 2 Corporation, as owner participant (collectively the "Lease");

WHEREAS, the Equipment that was subject to the Lease is described as ACF Industries Plastic Pellet Hopper Cars bearing road numbers ETCX158701 through ETCX158810, inclusive.

NOW, THEREFORE, Lessor hereby terminates the Lease to which that equipment is subject.


