MASTER LETTER AGREEMENT
(94-1, 95-1, 96-1)

THIS MASTER LETTER AGREEMENT (94-1, 95-1, 96-1) (the "Agreement") is made by the undersigned as of the 17th day of September, 2012, and relates to the transactions (the "Transactions") contemplated by:

(i) that certain (x) Participation Agreement (Phillips Trust No. 94-1) dated as of September 1, 1994, among Phillips 66 Company ("Phillips 66") (successor in interest to Phillips Petroleum Company), as Lessee, Wilmington Trust Company ("WTC"), as Owner Trustee, Wells Fargo Bank, National Association ("WFB") (as successor in interest to First Union Commercial Corporation), as Owner Participant, U.S. Bank National Association (successor in interest to Shawmut Bank Connecticut, National Association), as Indenture Trustee and JP Morgan Chase & Co. (as successor in interest to Chemical Bank), as Interim Loan Participant, and (y) Equipment Lease Agreement (Phillips Trust No. 94-1) (as amended, modified and supplemented from time to time, the "1994 Lease") dated as of September 1, 1994, between WTC, as Owner Trustee acting as Lessor, and Phillips 66 Company, as Lessee;

(ii) that certain (x) Participation Agreement (Phillips Trust No. 95-1) dated as of August 10, 1995, among Phillips 66, as Lessee, WTC, as Owner Trustee, WFB, as Owner Participant, U.S. Bank National Association (successor in interest to Shawmut Bank Connecticut, National Association), as Indenture Trustee, and U.S. Bank National Association (successor in interest to Shawmut Bank Connecticut, National Association), as Pass Through Trustee, and (y) Equipment Lease Agreement (Phillips Trust No. 95-1) (as amended, modified and supplemented from time to time, the "1995 Lease") dated as of August 10, 1995 between WTC, as Owner Trustee acting as Lessor and Phillips 66, as Lessee; and

(iii) that certain (x) Participation Agreement (Phillips Trust No. 96-1) dated as of December 30, 1996, among Phillips 66, as Lessee, WTC, as Owner Trustee, WFB, as Owner Participant, and U.S. Bank National Association (successor in interest to Shawmut Bank Connecticut, National Association), as Indenture Trustee, and (y) Equipment Lease Agreement (Phillips Trust No. 96-1) (as amended, modified and supplemented from time to time, the "1996 Lease" and together with the 1994 Lease and the 1995 Lease, the "Leases") dated as of December 30, 1996, between WTC, as Owner Trustee acting as Lessor, and Phillips 66, as Lessee.

Capitalized terms used herein without definitions have the meanings ascribed to such terms in the respective Participation Agreements referenced above related to the Transactions. Equipment schedules have been amended and restated to reflect changes in railcar marks and numbers and railcar casualties.

Phillips 66, as Lessee, has leased from WTC, as Owner Trustee acting as Lessor, certain railroad cars more particularly described on:

(i) Schedule A1 attached hereto pursuant to Lease Supplement (Phillips Trust No. 94-1) No. 1 of the 1994 Lease, evidence of which was filed with the Surface Transaction Board (“STB”) and the Registrar General of Canada (“RGC”) on such dates, and with respect to the STB, with such recordation numbers, as set forth on Schedule A attached hereto;

(ii) Schedule B1 attached hereto pursuant to Lease Supplement (Phillips Trust No. 95-1) No. 1 of the 1995 Lease, evidence of which was filed with the STB and the RGC on such dates, and with respect to the STB, with such recordation numbers, as set forth on Schedule B attached hereto; and

(iii) Schedule C1 attached hereto pursuant to Lease Supplement (Phillips Trust No. 96-1) No. 1 of the 1996 Lease, evidence of which was filed with the STB and RGC on such dates, and with respect to the STB, with such recordation numbers, as set forth on Schedule C attached hereto.

Since the date of the Leases, Conoco, Inc. and Phillips Petroleum Company were merged and became subsidiaries of ConocoPhillips (the “Guarantor”). In connection with such merger and pursuant to an amendment to the Participation Agreements, the Guarantor agreed to guaranty (the “Parent Guaranty”) the obligations of the Lessee under the Operative Agreements (such obligations, being the “Lessee Obligations”). Pursuant to other corporate restructurings related to the Guarantor and its subsidiaries, certain Guarantor affiliates were merged into Phillips Petroleum Company and Phillips Petroleum Company changed its name to ConocoPhillips Company, which continued to be the Lessee under the Leases. On or about April 30, 2012, Phillips 66 was spun off from ConocoPhillips Company (the “SpinOff”). In connection with the SpinOff, the Leases and related Operative Agreements to which ConocoPhillips Company was a party were assigned and transferred to Phillips 66 and Phillips assumed and became jointly and severally liable with ConocoPhillips Company for the Lessee Obligations. Thus, in connection with the SpinOff, ConocoPhillips Company remains liable for the Lessee Obligations.

In conjunction with the SpinOff and other corporate transactions referenced above and in order to comply with our respective obligations under the Participation Agreements and the related Operative Agreements, the undersigned acknowledge that each Lease and each of the related Operative Agreements remain in full force and effect in accordance with their terms and that such Operative Agreements are binding and enforceable against the undersigned in accordance with such terms.

The undersigned wish to show for public record this letter agreement and further acknowledge and agree that this letter agreement may be filed with the STB and the RGC in order to properly reflect the SpinOff and other corporate transactions referenced above and to protect and perfect the interests of the Owner Trustee and Wells Fargo under the Operative Agreements. In furtherance of the foregoing, the undersigned have caused this letter agreement to be executed by their officers thereunto duly authorized, as of the date first above written.

(iii) Schedule C1 attached hereto pursuant to Lease Supplement (Phillips Trust No. 96-1) No. 1 of the 1996 Lease, evidence of which was filed with the STB and RGC on such dates, and with respect to the STB, with such recordation numbers, as set forth on Schedule C attached hereto.

Since the date of the Leases, Conoco, Inc. and Phillips Petroleum Company were merged and became subsidiaries of ConocoPhillips (the “Guarantor”). In connection with such merger and pursuant to an amendment to the Participation Agreements, the Guarantor agreed to guaranty (the “Parent Guaranty”) the obligations of the Lessee under the Operative Agreements (such obligations, being the “Lessee Obligations”). Pursuant to other corporate restructurings related to the Guarantor and its subsidiaries, certain Guarantor affiliates were merged into Phillips Petroleum Company and Phillips Petroleum Company changed its name to ConocoPhillips Company, which continued to be the Lessee under the Leases. In connection with the SpinOff, the Leases and related Operative Agreements to which ConocoPhillips Company was a party were assigned and transferred to Phillips 66 and Phillips assumed and became jointly and severally liable with ConocoPhillips Company for the Lessee Obligations. Thus, in connection with the SpinOff, ConocoPhillips Company remains liable for the Lessee Obligations.

In conjunction with the SpinOff and other corporate transactions referenced above and in order to comply with our respective obligations under the Participation Agreements and the related Operative Agreements, the undersigned acknowledge that each Lease and each of the related Operative Agreements remain in full force and effect in accordance with their terms and that such Operative Agreements are binding and enforceable against the undersigned in accordance with such terms.

The undersigned wish to show for public record this letter agreement and further acknowledge and agree that this letter agreement may be filed with the STB and the RGC in order to properly reflect the SpinOff and other corporate transactions referenced above and to protect and perfect the interests of the Owner Trustee and Wells Fargo under the Operative Agreements. In furtherance of the foregoing, the undersigned have caused this letter agreement to be executed by their officers thereunto duly authorized, as of the date first above written.

This letter agreement may be executed in counterparts, each such counterpart shall be binding on the parties hereto, notwithstanding that the parties are not signatories to the same counterpart.
