

THIS **MEMORANDUM OF ASSIGNMENT OF SUBLEASES** is effective as of December 21, 2012, by and between **SUNTRUST EQUIPMENT FINANCE & LEASING CORP.** ("Assignee") and **BANC OF AMERICA LEASING & CAPITAL, LLC** (together with its successors and assigns, "Assignor"), with reference to the following:

Trinity Industries Leasing Company ("Lessee"), as lessee, and Assignor, as lessor, are parties to that certain Subleasing Consent and Amendment dated as of December 5, 2012 (as amended, the "Subleasing Consent and Amendment") whereby Lessee has pledged, assigned, transferred and granted to Assignor a continuing, first priority security interest in any and all Lease Agreements (as defined in the Subleasing Consent and Amendment) of the railcars described in Exhibit A hereto (the "Units"), together with all proceeds thereof, including proceeds in the form of goods, accounts, chattel paper, documents, instruments, general intangibles, investment property, deposit accounts, letter of credit rights and supporting obligations, and all books and records solely regarding the leasing or subleasing of the Units under the Agreement, the Schedules thereto and the Lease Agreements (each as defined in the Subleasing Consent and Amendment).

Assignor, as assignor, and Assignee, as assignee, have executed that certain Assignment and Specification of Assigned Lease Schedule dated as of the date hereof to that certain Master Assignment Agreement dated as of July 8, 2002 by and between Assignor and Assignee, pursuant to which Assignor has assigned to Assignee all of its rights and obligations under (i) that certain Rail Equipment Net Leasing Agreement dated as of December 5, 2012 and that certain Schedule No. 09003 dated as of the date hereof and (ii) the Lease Agreements (as defined in the Subleasing Consent and Amendment), in each case with respect to the Units.






