LEASE TERMINATION dated as of January 2, 2013.

**WHEREAS, NationsBank, National Association** (predecessor to *Bank of America, National Association*) as owner ("Owner") and **Grand Trunk Western Railroad Incorporated** (predecessor to *Grand Trunk Western Railroad Company*) as lessee ("Lessee") entered into a Lease of Railroad Equipment dated as of September 1, 1995 ("Original Lease"), as amended by an Amendment Agreement dated as of December 15, 1995, (collectively, "Lease") covering the twenty-six (26) SD70I diesel-electric locomotives, manufactured by the Diesel Division of General Motors of Canada Limited in London, ON in 1995, bearing the marks and road numbers **CN 5600 through CN 5625** ("Locomotives");

**WHEREAS**, to evidence the Lease of the Locomotives (i) a Memorandum of Lease of Railroad Equipment dated as of September 1, 1995 between Owner and Lessee was filed at the Interstate Commerce Commission (predecessor to the Surface Transportation Board) on September 27, 1995 at 11:15 A.M. under recordation number 19618 and (ii) the Original Lease was deposited at the Registrar General of Canada on September 28, 1995 at 8:56 A.M.;

**AND WHEREAS**, as of the date hereof, the Lessee has fully discharged and satisfied its obligations under the Lease of the Locomotives.

**NOW, THEREFORE**, the Owner hereby (i) terminates the Lease and (ii), for greater certainty, releases any security interest in the Locomotives.
