THIS MEMORANDUM OF ASSIGNMENT OF LEASE is made and entered into as of July 24, 2013, by and between SUNTRUST EQUIPMENT FINANCE & LEASING CORP. (the "Assignee") and FIFTH THIRD EQUIPMENT FINANCE COMPANY (the "Assignor"), with reference to the following:

Assignor, as Lessor, and Nova Chemicals Inc., as Lessee, have heretofore executed that certain Rail Equipment Lease Agreement dated as of July 24, 2013, and, pursuant thereto, that certain Schedule No. 4 dated July 24, 2013 (collectively, the "Lease"), pertaining to the railcars described therein and further described on Exhibit No. 1 attached hereto (the "Railcars").

Assignor, as assignor, and Assignee, as assignee, have executed that certain Assignment and Specification of Assigned Lease Schedule dated as of the date hereof to that certain Master Assignment Agreement dated as of May 16, 2008 by and between Assignor and Assignee, pursuant to which (a) Assignor has assigned to Assignee all of Assignor's rights and obligations under the Lease and Assignee has assumed from Assignor all of Assignor's rights and obligations under the Lease, in each case, solely with respect to the assigned Railcars, and (b) Assignor has sold the assigned Railcars to Assignee.

The parties hereto wish to show for public record this Memorandum of Assignment of Lease to provide notice of such assignment.




