

FULL RELEASE OF SECURITY INTEREST  
SURFACE TRANSPORTATION BOARD

The undersigned, acting on behalf of STATE STREET BANK AND TRUST COMPANY (successor to The Connecticut Bank And Trust Company, N.A.), as Indenture Trustee (the "Indenture Trustee"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge any and all security interests held by it on all railroad equipment and leases thereon, and leases thereof, granted pursuant to the Security Agreement - Trust Deed, dated as of December 15, 1988, originally described as under the Pullman Leasing Trust No. 88-3 and later described as under Rail Trust No. 88-3 (the "Security Agreement"), as amended, modified and supplemented, between Wilmington Trust Company, not in its individual capacity, but solely as Trustee, as Owner Trustee (the "Owner Trustee") and the Indenture Trustee.

The Security Agreement was duly filed and recorded with the Interstate Commerce Commission on December 30, 1988 under Recordation Numbers 16128-B. This document constitutes a termination of all railroad equipment covered by the Security Agreement and all supplements thereto filed with the Commission and with the Surface Transportation Board as secondary filings under Recordation Number 16128.


